WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Anuradha Mahila Shikshak Prashikshan Mahavidyalaya, Naiwala, Tehsil- Sanganer, Po-Teikaria, Ajmer Road, Rajasthan has submitted an application (code No. 05225) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting 575 Course of two year duration with an annual intake of 50 (Fifty Only) students on 22.11.2007.

NOW, THEREFORE, in exercise of the powers vested under Section 15 (3) (a) of the NCTE Act, 1993, the Morthern Regional Committee hereby grants recognition/permission to Anuradha Mahila Shikshak Prashikshan Mahavidyalaya, Naiwala, Tehsil- Sanganer, PC- Yaikaria, Ajmer Road,, Rajnsthan for conducting STC Course of elementary (level) of two year duration an accusal intake of 50 (Fifty Only) students from the academic session 2008-09 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:
- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Norther: Regional Committee.

The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

(iii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
