**Subject: - Directions for additional attempt for BHMS examination due to Covid-19 pandemic-reg.**

Sir/Madam,

With reference to the subject cited above, I am directed to inform you that Commission is in receipt of various representation across the Country from many students, Universities, Colleges asking for the additional attempt to appear for the examination as they have exhausted all attempts including mercy attempt under sub clause (iv) of regulation 11 of BHMS degree regulation 2015 (amended upto 2019) and they could not pass their exam due to adverse COVID-19 pandemic situation resulting into disturbed academic schedule.


As per the Homoeopathy (Degree Course) Amendment Regulations, 2015. "If a candidate fails to pass in all the subjects within four chances in examinations, he/she shall be required to prosecute a further course of studying all the subjects and in all parts for one year to the satisfaction of the head of the college and appearing for examinations in all subjects". The failed students coming in the ambit of above said provisions shall be required to prosecute a further course of studying all the subjects and in all parts for one year.

Further, the matter was placed in the Special Meeting of National Commission for Homoeopathy on 25<sup>th</sup> February, 2022 and decision of Commission is as under:-

*"Commission considered this unprecedented situation of Covid-19 pandemic and decided that students of any year of BHMS who could not pass examination in one or more subjects during year 2020 & 2021 as per specified number of maximum attempts and duration, shall be allowed 03 extra chances over & above including mercy chance"*

This is a one-time measure considered due to unforeseen Covid-19 Pandemic situation. Kindly acknowledge the receipt of the same.
